#### **CERT NEWS**

The Community
Emergency Response
Team (CERT) conducted
a quarterly drill in May to
simulate searching for
survivors of a mid-air
collision of two planes
over Monterey Bay.
Four teams searched



assigned grids in Monterey and Pacific Grove, found their dummy victim, stabilized the victim for transport, and returned to the Emergency Operation Center to debrief on the exercise. This is just one way in which members of the community are training to respond to emergencies. The CERT teams are called out occasionally to search for missing persons, particularly when a child or vulnerable adult is lost. The CERT teams have also been called out for lightning watch duty, for beach warnings and when the police and fire need assistance to keep the public away from dangerous situations. CERT has also trained residents to be prepared in their household for emergencies.

# Antonio Ferrante House (1928)

## 555 LARKIN STREET

The Antonio Ferrante House was built in 1928. Its design is consistent with the Spanish Eclectic Style found in Monterey during the 1920s. Typical elements include its parapeted



flat roof, Mission tiles above the covered porch, decorative metal balconet and stucco wall enclosing the front yard. Behind the residence is a wood-framed Western Style barn dated by the Monterey County Assessor's Office at c. 1900. Included in the historic designation, the barn is one of the few remaining examples of early outbuildings in the City.

Born in Isla de Femine, Sicily, Antonio Ferrante moved in 1903, with wife Angela, to Pittsburg, CA to work in the fishing industry. In 1925, the growing family relocated to Monterey and purchased the modest view-lot home on the hill. Antonio continued his work in the sardine industry now as an owner and captain of two Purse Seiner fishing boats, the Sea Queen and the A.A. Ferrante. The property's barn was utilized in his commercial fishing business.

The property has been passed down to Antonio and Angela's family members until being sold in 2017 to its current owners. Renovations have been undertaken to protect the structure while maintaining the charm of this lovely home.

#### UNDERGROUNDING UTILITIES COMMITTEE

#### **NCIP NEWS**

As the city determines the budget for fiscal year 2021-2022, the status of the Neighborhood and Community Improvement Program fund is unknown. Obviously, this has been a trying year for Monterey. While it is possible the city will finance the fund at the defined 16% of the Transient Occupancy Tax, the council may again decide to transfer the NCIP money to the general fund. The city budget will be approved in June. So, stay tuned. Likewise, the process for restoring funding for the numerous existing projects is unclear, whether to work the list beginning with the oldest, the most favored (garnered highest number of committee votes) or the most urgent (safety concerns). Be assured, Old Town's Larkin Park project which was approved in 2015 is still on the list awaiting action. *Thankfully a few urgent 2021 NCIP jobs have even been completed - green belt fuel abatement and the pedestrian crossing warning near the bus transit plaza*.
